A análise baseada na diferença entre gêneros (*mainstreaming*) avalia e compara as repercussões de diversas políticas e medidas legislativas e governamentais na mulher e no homem em diferentes setores, por exemplo, na saúde e na educação. Os orçamentos constituem, então, um dos diversos aspectos que podem fazer objeto de uma análise baseada na diferença entre gêneros.
